## Subject:Exemption of duties and taxes on imports by the United Nations, UNBodies and Specialized Agencies of the United Nations for their officials use.

I am directed to state that it has been brought to the notice of the Board by the UNDP, that there is some confusion in some of the offices of the Customs Department as to whether duties and taxes are leviable on the imports of the United Nations, U.N. Bodies and U. N/ specialized Agencies for their official use.

It is hereby clarified that the United Nations, U.N. Bodies and U.N. Specialized Agencies are exempt from payment of all kinds of import duties and taxes on imports made for their official use under the Conventions on the Privileges and Immunities of the United Nations, Convention on the Privileges and Immunities of the Specialized agencies, Agreement between the United Nations and the Government of Bangladesh and the United Nations (Privileges and Immunities) Act, 1948 (Act No. XX of 1948) as adapted in Bangladesh.

You may, therefore, allow clearance of all imports made by the aforesaid organizations for their official use without charging any import duty or tax.
